Sl. No.	The school is directed to ensure that :
1	Total number of sections for Bal Vatika shall be restricted to 3, i.e. 1 section each for Bal Vatika classes I, II, & III respectively. The total number of sections of the school shall be restricted to 32 for classes I to XII of which not more than 1/3rd sections (including Bal Vatika) may be used for senior secondary classes (XI & XII). Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of > 500 sq feet dimension.
2	The school has provided video link (https://drive.google.com/file/d/1-ukanzedjIPTB68XX31jxUsG238FrazU/view) covering boundary wall through mail. The height of concrete boundary wall in some part is seen less than prescribed height of 6 feet due to the design on the wall. Hence the school is directed to construct concrete boundary wall upto 6 feet from ground without any gaps/grills and submit the videographic compliance within 3 months.
3	The school has shown only one CWSN toilet which is a regular cubicle converted into CWSN toilet, but it is very small and narrow and there is no room for a wheelchair/walker to navigate. Separate toilets for CWSN, boys and girls are not constructed by the school. Thus the school is directed to construct Separate toilets for CWSN, boys and girls in every floor as per provisions laid down in RPWD Act and guidelines issued by the Board and submit the videographic compliance within 3 months.
4	The school is a residential one and have hostels for boys and girls. Hence the school is directed to cordon off the hostels from the school. The school is also directed to make separate entries for school, both hostels and upgrade the hostels as per Board's circular No. Aff-24/2023 dated 01-09-2023 and submit the videographic compliance within 3 months

5	The School does not have a fully equipped separate Maths lab with proper equipment, workstations and sitting arrangement as per SoP. Separate workstations with appropriate fixture / installations for separate sections of Physics, Chemistry & Biology are not seen in Composite lab. Piped gas supply and safety features like fire extinguisher, exhaust fans and emergency exit are not seen in Composite lab and Chemistry lab. Hence the school is directed to upgrade the labs as per SoP issued by the Board and submit the videographic compliance within 3 months.
6	The total number of computer mentioned in the infrastructure details are not seen in the videography and there is no appropriate sitting arrangement is seen in the videography. Hence the school is directed to upgrade the lab as per SoP issued by the Board and submit the videographic compliance within 3 months.
7	Library is seen understocked and no proper reading area for students and staff. Hence the school is directed to upgrade the library as per SoP issued by the Board and submit the videographic compliance within 3 months.
8	The school shall conduct training of its teachers with CoE Bhubaneswar within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
